Kindly refer to this office order No. F.8(03)/2024/DAM/MR/ELECTION/1049-1057 dated 05.12.2024 vide which Director has appointed the undersigned as the Electoral Registration Officer (HQ) in pursuance of Rule 4(1) of Delhi Agricultural Produce Marketing (Election) Rules, 2000 to conduct the election of members as mentioned below for 06 APMCs:

02 Members from Traders and Commission Agent Constituency.

01 Member from Weighmen and Measures Constituency.

In pursuance of the provisions contained under Sub-Rule (2) of Rule 4 of the Delhi Agricultural Produce Marketing (Election) Rules, 2000 and according to the format as prescribed under Rule 5 of the said Rules, the existing Electors List shall be revised / updated.

As per procedure laid down under Delhi Agricultural Produce Marketing (Election) Rules, 2000, some of the following points are brought to your notice:-

- 1. Before sending the Electors List by the concerned ERO to this office, it must be checked, verified and signed. The entries to be Addition / deletion / changes must be marked. Every page should have to be signed and stamped by the ERO.
- 2. A separate list of be addition / deletion / changes should be prepared, signed and stamped by the ERO concerned.
- 3. The entire list should be in Hindi and in the same format as already been prepared in previous years. A soft copy in Pen Drive / E-mail is also required and same may be forwarded to this office.
- 4. The hard copy of the entire list (printed copy) including the list of be Addition / deletion / changes should be sent to this office.
- 5. The Elector's List may be prepared on the basis of schedule provided in the aforementioned Order. It is emphasized that the Final Voter List should be duly checked, signed and stamped by the

respective ERO of the concerned constituency and shall be sent to this office as per schedule provided

in the Order. The copy of Electoral Roll prepared during last election is enclosed herewith (Soft copy emailed).

This may be treated as most urgent.
